# ACS CCC - 2021-2022 Program Evaluation Executive Summary



The American Cancer Society's Comprehensive Cancer Control Initiative (ACS CCC) has been funded since 2001 to improve capacity for CDC's National Comprehensive Cancer Control Program (NCCCP) recipients and their coalitions through technical assistance and training (TAT). The ACS CCC addresses five core strategies as outlined in DP18-1805 (needs assessment, evidence-based TAT framework, national partnerships, TAT implementation and evaluation) to build NCCCP program and coalition capacity to implement the following effective approaches in their state and local communities:

- · evidence-based interventions (EBI)
- · policy, systems and environmental (PSE) change
- · dissemination and training for partners
- using data and evaluation

This report details the ACS CCC activities, including funded activities implemented by the NCCRT, and progress towards outcomes occurring in the fourth year of the technical assistance and training initiative (October 2021 - September 2022).





### **RESOURCES**

Dissemination continues to be a high priority strategy to engage NCCCP programs and coalitions in Year 4. This summer, the ACS CCC and the CDC released the co-branded Policy Systems and Environmental Change Guide (PSE Guide) update. This new guide is informed by a literature review and the author's comprehensive cancer control program and evaluation expertise. The revised PSE Change Model in Comprehensive Cancer Control is used as a guide to provide practical CCC examples and action-oriented prompts to inform implementing PSE change interventions.

The PSE Guide has been downloaded 191 times since its release.

ACS CCC hosted a summer webinar series on PSE Change in CCC referencing the PSE Guide. The series engaged **444 attendees** from July to Sept. 2022. https://www.acs4ccc.org/summer-2022-webinars-on-pse-change-for-ccc-coalitions/
